Loan went up from approximately 3 to 3.5% up in April, but we are still paying the old quarterly amount. Doug Hughes will work with endowment treasurer (Barb Jensen) to reconcile our loan with the Endowment fund.

Planning for annual congregational meeting

Sunday Feb 23rd is annual meeting and presentation of slate of board candidates. Due to prior commitment Erika will only be available for start of meeting. Board members going off are Suzanne Goffredo, Doug Hughes, Bob Goard (Filling in for Bob Smith), Charlie Cormier (filling in for Dave Hyde), Greg Dora (filling in for Erin Schoenberg).

Packet with slate has to be mailed out by January 26th.

The Annual Report contains reports from groups and committees at UUFBR. Reports have to be in by mid January - 1-3 paragraphs letting the congregation know what the committee / task force has done.

Temporary Secretary Greg Dora will get them by Feb 1 and give to Lynn by Feb 3rd.

Congregational town hall meetings planned for Jan 5th and Jan 26th to involve the congregation in building the budget.

Discernment

Minister evaluation will be done this year in January. The Board will do a congregational and self evaluation in February at the transitional Board meeting which will help to bring new board members up to speed. Doug Hughes mentioned that the old board should attend the February meeting to help with the transition.

Decision made to keep one printed Board Binder as most of the board use online / electronic versions.

It was suggested that at the board transition meeting we do a 15 minute demo of our UUFBR website and our wiggio tool.

Planning to approach Endowment to ask them to cover the \$5,000 insurance deductible. Alexis is offering to run a campaign to raise money of the sign we deserve.
